## Sunday, October 15 Training Session, Carbondale

Greenfield fire crews assisted Lackawanna County EMA at a training session and drill for Emergency Decontamination that was held in Mayfield. Firefighters from around the area assembled at Wm. Walker Hose Company to learn how to participate in the county-wide decontamination team. Greenfield sent its decon truck to the event to assist.

## Medical Emergency, Greenfield

Greenfield Ambulance responded to a medical emergency in the township just before noon. Greenfield Ambulance transported one township resident to Marion Hospital in Carbondale.

Greenfield Police arrived on scene before the fire equipment and determined that the activation was accidentally caused by food cooking and all units were released before arrival.
