Week In Review

Tuesday, April 7

Medical Emergency Assist to Clifford EMS

At 3:30 p.m. Greenfield's ambulance assisted Clifford EMS on Route 106. Greenfield's ambulance along with Cottage Paramedic transported one patient to a local hospital.

Smoke Investigation on Lee road in Greenfield Township

At 6:00 p.m. Station 24 was dispatched to Lee Road in Greenfield Township for a smoke investigation. Greenfield's engine, tanker and ambulance responded to the scene. Incident was determined to be a faulty wire.

Welfare Check on Arnold Road

At 6:30 p.m. Greenfield police requested Station 24 for investigation on Arnold Road. Resident was checked on and no emergency services needed.

Thursday, April 9

Motor Vehicle Accident Route 106 Clifford Township

At 12:50 p.m. Greenfield's engine and ambulance responded to assist Station 18 Clifford Fire on a motor vehicle accident on Route 106 in Clifford Township. Greenfield's engine provided traffic control while Clifford's rescue handled the incident. Greenfield's EMS handled patient care, and no transports were needed.

Medical Emergency on Decker Road

At 1:42 p.m. Greenfield's ambulance and Lackawanna Paramedic responded to a medical emergency on Decker road. Greenfield Ambulance and Paramedic transported patient to city hospital.

Brush Fire on Old School House Road Clifford Township

At 4:27 p.m. Greenfield's engine and tanker responded to assist Station 18 on a brush fire on Old School House Road. Greenfield's engine and Tanker 24 provided hand lines and water for brush trucks.

Medical Emergency Decker Road

At 4:30 p.m. while the engine and tanker were out on the assist, Greenfield's ambulance and Cottage Paramedic was dispatched for second EMS call to Decker Road. Greenfield Ambulance along with Paramedic transported one patient to local hospital.

April 10

Medical Emergency on Spedding Road

At 2:56 a.m. Greenfield's ambulance and Cottage paramedic responded to a medical emergency in Greenfield Township on Spedding Road. Greenfield transported one patient to a city hospital with Paramedic on board.

Motor Vehicle Accident in Fell Township

At 9:10 p.m. Greenfield's ambulance was dispatched to a motor vehicle accident in Fell Township for five people with injuries. Due to all BLS units on the dispatched, Scott Ambulance was placed on stand-by to cover area while everyone was on the incident. Greenfield's crew assisted Cottage Paramedic with patient care and helped load everyone into their Ambulance. Greenfield's ambulance was placed back in service to handle calls in the area.

Saturday, April 11

Medical emergency Old Maple Road

At 10:06 a.m. Greenfield's ambulance along with Cottage Paramedic responded to a medical emergency in Greenfield Township on Old Maple Lane. Greenfield's ambulance transported one patient to a local hospital with Paramedic on board.

Sunday, April 12

Medical Emergency on Old Maple Road

At 1:30 p.m. Greenfield's ambulance responded to a medical emergency in Greenfield. Greenfield's EMS transported one patient to a local hospital with basic life support only.

Brush Fire on Ruthland Avenue

At 6:30 p.m. Greenfield's engine, tanker and ambulance responded to a brush fire on Ruthland Avenue in Greenfield Township. On the investigation, fire was out on arrival.

Medical Emergency at Greenfield Station

At 7:00 p.m. Greenfield's ambulance was dispatched for a medical emergency to meet at Greenfield's station while patient was being transported POV. Greenfield's ambulance along with Cottage Paramedic transported one patient to a local hospital.

Monday, April 13

Working Structure Fire on Tinkerbrooke Road in Clifford Township

At 6:30 p.m. Greenfield Engine, Tanker and Ambulance were dispatched to assist Station 18 Clifford Fire on a working structure fire on Tinkerbrooke Road. Ladder 18 arrived on scene reporting two-story residential wood frame structure heavy smoke condition coming from division 2. Greenfield's engine crew was assigned interior attack off Clifford's ladder while Engine 24 laid 1200 ft of 5-inch to local pond to establish water supply due to tight roads for tanker shuttle. Greenfield's EMS handled rehab and tanker assigned back up water supply to Clifford's tanker crews that operated for over three hours.

Tractor Trailer Fire Route 106 Fell Township

At 10:20 a.m. Greenfield's tanker was dispatched for a tractor fire on Route 106 in Fell Township. Greenfield's tanker provided water supply for Engine 61-3.

Smoke Investigation Interstate 81

At 11:15 a.m. Greenfield Station was dispatched for a smoke investigation at mile marker 203 north on Interstate 81. The incident was determined to be unfounded.

Thursday, April 16

Medical Emergency on Creamery Road in Greenfield Township

At noon Greenfield's ambulance was dispatched along with Cottage Paramedic to Creamery Road. Greenfield's ambulance transported one patient to a city hospital with paramedic on board.

Brush Fire McCarthy Road Clifford Township

At 1:06 p.m. Greenfield's engine and tanker responded to assist Station 18 on McCarthy Road in Clifford Township for a brush fire. Greenfield's engine pulled attack line to put out the heavy fire and foamed area. Greenfield's tanker provided water supply to Greenfield's engine.

Brush Fire Hickory Ridge Road in Greenfield Township

At 2:50 p.m. after returning from assist to Clifford, Station 24 dispatched engine tanker and ambulance to Hickory Ridge Road. Chief 24 arriving on scene requested next two brush trucks and a tanker out of Clifford fire. Brush fire contained over two acres.

Friday, April 17

Working Structure Fire at Bear Swamp Road in Clifford Township

At 9:35 a.m. Greenfield's engine, tanker and ambulance were dispatched to a two-story residential wood frame structure with heavy smoke coming from the basement. Greenfield's crew was assigned interior duties while the engine and tanker handled water supply. Greenfield EMS handled rehab.

Medical Emergency on Route 106 in Clifford Township

At 10:55 a.m. while Greenfield's EMS was handling the rehab, Greenfield's ambulance was dispatched for a medical emergency on Route 106. Next due BLS was requested to handle the call.

Saturday, April 18

Brush Fire on Manning Road in Scott Township

At 3:30 p.m. Greenfield's engine and ambulance were requested to assist Scott Fire on a large wooded brush fire on Manning Road. Greenfield's engine crew assisted in setting up a water supply then went into the scene to assist in overhaul and mop up with brush units. Greenfield's EMS handled rehab for the incident.

Sunday, April 19

Search Lee Road in Greenfield Township

At 1:30 p.m. Station 24 was dispatched to assist Greenfield's Police for a search on Lee Road. Individual was found when Chief 24 arrived on scene.

ATV accident Clifford Township

At 3:30 p.m. Greenfield's ambulance was dispatched to assist Clifford Fire on an ATV accident on High Bridge Road in Lenox Township. Greenfield's ambulance along with Cottage Paramedic transported one patient to a city hospital.
