**Weekly Report**

**September 28 – October 10, 2009**

**Monday, September 28:**

At 12:33 p.m. Greenfield Tanker responded to Lakeland High School to assist Scott Twp. on a possible structure fire. Station 36 units arrived and found a light smoke condition in the science lab. Station 36 units found an overloaded microwave, vented the smoke out of the building and all units cleared the scene within one hour.

**Wednesday, September 30:**

At 4:10 p.m. Greenfield units responded to Finch Hill Corners for a motor vehicle accident involving an overturned vehicle. Chief 24 arrived and found an overturned vehicle with the operator out of the vehicle with no one injured. Engine 24 arrived and handled the hazards on scene and Ambulance 18-9 retrieved a refusal from the patient. All units cleared the scene within one hour.

**Thursday, October 1:**

At 2:11 a.m. Greenfield Ambulance, assisted by Cottage Paramedics, responded to a medical call involving an elderly female. Greenfield Ambulance and Cottage Paramedics transported a female to a local hospital. All units cleared within one hour.

At 8:23 p.m. Greenfield Tanker was dispatched to assist Scott Twp. Units for a possible structure fire on Tompkinsville Road. Scott units arrived and found a large pile of lumber and scrap wood burning with hay bales nearby also igniting. Greenfield Tanker assisted with water supply. All units cleared within two hours.

**Saturday, October 3:**

At 12:39 p.m. Greenfield Twp. Ambulance was dispatched to assist Clifford Fire and EMS for a two car MVA at the intersection of Rts 106 and 374. Greenfield units cleared within one hour with EMS on scene obtaining refusals from all occupants of the vehicle.

**Sunday, October 4:**

At 4:39 a.m. Greenfield Engine, Tanker and Ambulance were requested to assist Clifford Fire for a working structure fire on Cameron Hill Road in Lennox Twp. Greenfield units cleared the scene within two hours.

**Tuesday, October 6:**

At 12:54 p.m. Greenfield was requested by Wayne County to assist Waymart Fire for a Haz Mat Incident involving a black substance on the roadway stretching from Waymart Corners to Honesdale. Greenfield Engine responded as the Rapid Intervention Team to stand by to assist if needed. Greenfield Units cleared within two hours.

**Friday, October 9:**

At 6:38 p.m. Greenfield Ambulance responded to Lakeland High School for a stand by for the Lakeland Chiefs Football game.

**Saturday, October 10:**

At 6:44 a.m. Greenfield Engine responded to assist Waymart as the Rapid Intervention Team for a porch fire on Rt 6 next to the Dollar General. Waymart units arrived on scene and quickly extinguished the fire and Greenfield Engine was placed back in service within minutes.

At 7:35 p.m. Greenfield Ambulance was requested to assist Clifford Fire and Ambulance with a motor vehicle accident involving multiple patients. Greenfield Ambulance transported two patients to the local trauma center. Greenfield units cleared within two hours.
